The York BID Company membership rules

- 1)** Every BID Levy Payer or equivalent financial contributor is eligible to become a member.
- 2)** Where a levy payer has multiple hereditaments he/she is entitled to one membership/one vote.
- 3)** To become a member, a levy payer must complete the appropriate registration form.
- 4)** To become a member a levy payer/financial contributor must have paid their levy dues in full.
- 5)** Members must work in the best interests of the company and its objectives and in supporting the agreed Business Plan. Rules set out in the BID Company Articles of Association and the Companies Act 2006 relating to the conduct of members/directors will also apply.
- 6)** Registered members interested in furthering their involvement with the York BID can formally apply to be a Board Director. This is subject to vacant seats and in accordance with the items 24.1-24.7 of the York BID Company Articles of Association (retirement and rotation of directors).
- 7)** Members will not be able to stand for the position of Chair unless they have served a minimum of a year as a Board Director.
- 8)** Members must declare any conflicts of interest.
